All members are required to hold active membership in the Academy of Model Aeronautics (AMA). AMA Park Flyer memberships are accepted. If the aircraft being flown no longer comply with the AMA Park Flyer requirements, an upgrade to AMA Full membership is required.

The MPRCF membership year runs from February 1, 2024, through January 31, 2025. Dues, for new members only, are prorated as follows: Members joining between February 1 and July 31 pay 100% of the listed dues; Members joining between August 1 and October 31 pay 50% of the listed dues; Members joining on or after November 1 pay 100% of the listed dues, however, their membership will be extended through the end of MPRCF's subsequent membership year, or January 31, 2026.
